





## **Eternum Analytics Qualifier Guide**

Possible Qualifiers:
B1: The target analyte is detected in the calibration blank or method blank at or above the limit of quantitation, but the sample result is below the limit of quantitation.
B2: The target analyte is detected in the calibration blank or method blank at or above the limit of quantitation, but the sample result is below the maximum allowable concentration.






